# SERVICES FOSTER CARE PROGRAM PROVIDES

# • Foster Application

- Support Workers - Respite Workers

- Transportation - Four Bed Units

- Adoption: We offer support through providing a referral is necessary.

## Support Worker is:

Criteria for persons who work with foster children. 18 (1) the licensing agency shall ensure that any person who, on behalf of an agency or a licensee works directly with foster children. Who may have unsupervised access to foster children as defined under the Child and Family Services Act: Part 3, requirements and Standards.

### Respite Worker is:

A respite worker is a person used by Foster Parents for less than four days per month for short intervals of time off during the day to day care of the Foster children. Respite Workers must adhere to the duties and responsibilities given by the agency worker via respite request.

### Transport Driver is:

A person with a valid driver license and registration. Who can transport children in care to and from appointments, visits on behalf of foster parent who are unable to provide transportation? The transport drivers will need to be available on an on-call basis.

### Four bed units

Alternative placement that meets the needs of our youth in care ranging from ages 0 to 11, 11 to 17.



### **INTAKE PROCESS:**

If you wish to foster, interested individuals or couples will have to complete an application to foster. As well as attending a compulsory agency orientation. If you wish to be support, respite, family care services or transportation you will need to provide a resume, valid driver's license, and current ID's.

We will also consider the following: experience in child welfare or group home setting. Plus relevant training but not exclusive to counseling skills, F.A.S. and F.A.E., First Aid, C.P.R. training, suicide prevention and non-violent crisis intervention. Plus agree to additional expectations provided by the agency.



### **REQUIREMENTS:**

Individuals who apply to be support, respite, transport and family care services must submit their resume to our agency. If their resume reflects any child welfare experience our agency worker may invite the applicant for an interview. The application will then be further processed and compulsory checks by our Foster Care Worker will be conducted.
